**DEPOSIT/FINAL PAYMENT:** A deposit of \$300 per person is required to secure a reservation; A second deposit of \$500 is due August 15, 2016. Final Payment is due no later than May 1, 2017

**DEVIATIONS:** Any requests for deviations must be in writing and received by MWT Associates, Inc. A non-refundable \$200 per person deviation fee must be paid prior to any arrangements.

**AIR:** Roundtrip air to Boise, Id can be offered from: BOS, JFK, LAX, SAN, SJC. If you would prefer that MWT arrange your airfare roundtrip to Boise, Id, please advise no later than November 1, 2016.

Any request for air after November 2, 2016 will be subject to the air increase at that time plus, a \$125 administration fee.

**TRANSFERS:** Airport/hotel transfers are provided on Days 1 and 10.

**NOT INCLUDED:** Not included airfare, alcohol, laundry, telephone and all items of personal nature.

**DOCUMENTATION:** A valid government picture ID or Driver's License or a passport valid six months after the return date of your travel is required. All **non-USA** residents will require a valid passport.
